1. Eligibility Notification

The undersigned hereby acknowledge that they have been made aware of the ruling that accepting any award money above and beyond their expenses in the St. Lawrence International Junior Carp Tournament, held in St. Lawrence County on August 16-18, 2012, may affect eligibility status in National Collegiate Athletic Association (NCAA) sports. Accepting prize money in any competition can have an effect on eligibility of any sport, and can only be appealed to the NCAA at the time of enrollment. The NCAA rules on a case-by-case basis.

We have been notified by the New York State Athletic Association that accepting prize money does not affect eligibility for High School Athletics in New York State.

2. Permission to photograph and/or videotape
